It is hypothesized that CELL shall be defined within the following scope.


- a. "CELL" shall be considered as most fundamental "Super Matter".


2.CELL Differs From ATOM?

5.Philosophy of Dark flame?





10.2.Philosophy Of "GOD" Particles?

 - "A" Photon (Neutral Charge)





- EMR shall be characterized by pure "TRIANGULAR" shape wave and not as sine wave.
- EMR shall always exist in "Three-in-one" configuration of Optic, Electric, Magnetic field and sub field component never exist alone.

The Three field component Optic, Electric, Magnetic of EMR shall be considered existing symmetrically displaced by 120⁰ and subject to Sustained Oscillation.





10.7.New Philosophy Of EMR Antenna?


In conventional definition Antenna is considered as a Electric Transducer for converting Electromagnetic wave energy into Oscillating Current and vice Versa. Antennas are of different types according to specific purpose of handling the respective nature of Electromagnetic wave and region such as RF Antenna, UHF Antenna, Microwave Antenna, Radar antenna etc.

It is hypothesized that the meaning of word "Antenna" shall not be considered as mere transducer but shall be considered having elaborate meaning. Antenna shall be defined with in the following scope.

- Antenna shall mean sense of Perception.
- Antenna shall mean as device for "THREE-IN-ONE sensory perception" (i.e) a device used to convert Optic, Electric, Magnetic field component into Electric oscillating current and vice versa.
- The antenna shall mean a device which transmits or receives EMR of at constant speed of 3x10⁸ m/s.
- Antenna structure shall be considered as TRIPOD base.
- Any Device which transmits Electromagnetic wave energy which speed less than 3x10⁸ m/s shall not be considered as Antenna but shall be considered as "Species" to Antenna (or) "AERIAL".
- Any antennas meant for propagating only electric and magnetic field component shall not be considered as an antenna. Such a device shall be called as aerial.

10.8. Philosophy of Human Tri-Pole Antenna?!...

Millions of human spread all over the world shall be considered as local BTS tower directly connected to "MARS MASTER ANTENNA" through inbuilt Human Antenna. Human Antenna shall be considered as "Three sensory perception device" and capable transmitting, receiving Electromagnetic wave energy at the speed of 3 x 108m/s or slightly less and directly linked to master antenna. It is hypothesized that the electric pulse derived from human antenna shall be considered as an energy source for the function of the human heart. Further it is hypothesized that the frequency of electric pulse is closely associated with frequency of natural oscillation of neutrino particles. Human Antenna shall be considered as Mobile TRIPOLE like structure tuned to MARS Master Antenna. The philosophy of MARR (Multi Axis Radio Range) might be derived from the philosophy of Tri-Pole MARS Master antenna. In fact MARR shall be newly translated as Mu axis radio range. MU shall mean THREE which is related to three domain of optic, electric, magnetic of electromagnetic radiation.

Case study on Heart Anatomy and Heart function

Case study shows that each heart beat is triggered by an NATURAL ELECTRICAL PACE MAKER i.e. a group of cells in the heart that have the ability to generate electrical activity. They cause electrical impulses to spread over the heart and make it contract.

The natural pace maker shall also be called as ELECTRICAL HEART. Each heart beat is started electrically at SN (Sinoatrial Node). Then the electrical pulse is carried to AVN (Atrio Ventricular Node) and relayed to ventricles and right bundle branches to the heart muscles for making natural rhythm of heart.

Case study show that the SN is found located in the to of right ATRIUM. From atrium specialized group of cells that carry the electrical charge lead off to the rest of the heart.

It is hypothesized that the energy point of the heart shall not be beginning at atrium and it shall be slightly located outside the heart and probably connected through nerves leading to the centromere of TRIPOLE ANTENNA. In brief it shall be stipulated that the centromere of Tripole antenna shall be connected to the point of atrium to route NERVE. The philosophy lies that if the energy point is derived from atrium then while replacing natural pace maker with artificial pace maker the centromere of energy point connected to Universe energy source shall be lost. Where as if the centromere is located outside the atrium then replacement of artificial pacemaker shall continue to have connectivity to the centromere and there by the connectivity to the tripole antenna shall not be lost.

Case study shows that after transplant of original heart with pacemaker and artificial heart some times HRV (Heart Rate Variation) influenced by dislocation of natural connectivity with tripole antenna.

Further it is hypothesized that the heart pulse being regulated by THREE NODE rather than two node as stipulated in case study (SN, AVN). The three node shall be considered as the tripole antenna consists of right nipple, left nipple, navel connected star point which is called as centromere. From centromere the tiny electrical pulses shall be considered as fed to the atrium through nerves.

10.9. Philosophy Of Three Domain Of Life?

It is hypothesized that MARS MASTER ANTENNA shall be considered as "Multi Axis Antenna" comprising of three Domain System for total coverage of three regions of spectrum. (i.e) UV Region, Visible Region, IR Region and tuned to respective direction in the material Universe (Region-III). 

- A-Pole Proton (Neutral Charge)


10.14.Non-Living Matter Has Antenna?









- "Aerial" shall mean Image and light and travels at speed of 2.99 x 10⁸ m/s


10.25.Can Human See Both Sides Of The Moon From Earth?!...





10.30.EMR Differs From Cosmic Radiation?







• Magnetic- due to influence of PROTON





It is hypothesized that Human shall be considered as having three species evolved in three different stages. The philosophy of three species human evolved during the course of space and time shall be narrated as below.





Blood shall be defined as Natural EMR Product composed of three fundamental particles Photon, Electron, Proton having varied Cell Mass from person to person.



It is hypothesized that the philosophy of spectral region of space shall be considered as existing in Pyramid like shape rather circular in shape.



- A massive breakage in the earths magnetic field causing enormous geomagnetic storms. It is speculated that these magnetic storms can trigger changes in the earth's crust which may lead to increase in latitudes, earthquakes, and volcanic eruptions.
